#### The challenge

As Shift4 scaled globally—monitoring transactions across stadiums, restaurants, e-commerce, and more—their legacy AML systems couldn't keep up.

Their compliance team was buried in noise:

- An overwhelming number of low-quality alerts
- 89% false positive rate
- Difficulty meeting regulatory reporting deadlines (like same-day SARs in Malta)
- Inability to support new product launches due to data ingestion limitations

#### The solution: Cognitive AI at the core

In late 2023, Shift4 selected ThetaRay as their technology partner for AML transaction monitoring. By Q1 2024, ThetaRay's Cognitive AI platform was fully deployed across their European operations.
